Paramedic School Reimbursement Contract

This serves as an agreement between Thomas McGrady and the Georgetown Fire Protection District (GFD).

Whereas the GFD desires firefighters to become paramedic certified and Thomas McGrady desires to become paramedic certified.

This agreement mutually benefits both parties and will provide funding for Thomas McGrady to become certified as a paramedic through NCTI, which begins February 8, 2024, and completes August 23, 2024.

The Georgetown Fire Protection District agrees to pay the sum not to exceed \$14,000 towards Thomas McGrady's Paramedic Training Program.

Thomas McGrady agrees to successfully complete the Paramedic Training Program and become certified as a Paramedic in El Dorado County.

If, for any reason, Thomas McGrady does not successfully complete the Paramedic Program and becomes certified in El Dorado County, he agrees to pay GFD at a minimum of \$250/month until the total tuition amount is reimbursed to GFD.

If Thomas McGrady completes the Paramedic Training class, becomes a Certified Paramedic, and remains working for GFD for over six years, there will be no required tuition payback to GFD.

Suppose Thomas McGrady becomes a Certified Paramedic through this agreement, and chooses to leave GFD before his six-year commitment; then he will be required to reimburse GFD per the following schedule and again at the minimum of \$250/month:

Leaves before being a Certified Paramedic for one year	\$Full Amount
Leaves between 1 and 2 years of being a Certified Paramedic	\$11,667
Leaves between 2 and 3 years of being a Certified Paramedic	\$9,334
Leaves between 3 and 4 years of being a Certified Paramedic	\$7,001
Leaves between 4 and 5 years of being a Certified Paramedic	\$4,668
Leaves between 5 and 6 years of being a Certified Paramedic	\$2,355

If Thomas McGrady fails to meet the required payback agreement at any time, both parties agree to attempt arbitration to come to a resolution. The losing party will pay all costs associated with the arbitration.

Suppose either party chooses to appeal the arbitrator's decision to a full court proceeding; in that case, the losing party will be subject to all costs of the winning party, including legal fees.

The undersigned agree to this agreement of their own will.





Ready to respond as the district's "first out" apparatus, Squad 51 is a new, state-of-the-art fire engine. This smaller, yet mighty apparatus is a testament of GVF's commitment to efficiency, safety and progress.

Squad 51 is built on a robust Dodge 5500 chassis, perfectly balancing size and power. Despite its compact frame, it boasts an impressive capacity of 328 gallons of water, ready to tackle fires with efficiency and speed. Its size is not just a feature but a strategic advantage, allowing it to navigate challenging terrain and narrow private driveways of the community with less risk of damage and greater ease.

The introduction of this vehicle is a game-changer for days with minimal staffing. Designed with the newest tactics in mind, Squad 51 can be driven and operated with only one person. Although responding to any emergency with one firefighter is a safety concern in itself, this is a crucial advancement, ensuring that even on days with limited personnel, GVF's response to emergencies remains swift and reliable.
