We are posting through the Firefighter Candidate Testing Center and will keep the posting up from now on.

The volunteers continue working with us to fund the development of the type 6 and the training center.

Volunteer training is going well.

Allocation Agreement Among Participating Entities Collectively

WHEREAS El Dorado County, Placer County, Georgetown Fire Protection District, El Dorado County Water Agency, Georgetown Divide Public Utility District and Placer County Resource Conservation District (collectively, "Participating Entities") were and are affected by the 2022 Mosquito Fire (referred to herein as "the Fire"); and,

WHEREAS the Public Entities claim that these damages were caused by the actions and/or inactions of PG&E Corporation and Pacific Gas and Electric Company (collectively "PG&E"), and for which each Public Entity has filed a lawsuit to recover damages from PG&E ("Case");

WHEREAS the United States Federal Emergency Management Agency ("FEMA") and the California Governor's Office of Emergency Services ("CalOES") have obligated funds, will obligate funds, have made payments, or will make monetary payments to Participating Entities in connection with public assistance programs resulting from federal or state emergency/disaster declarations and/or resulting from the Mosquito Fire ("Disaster/Public Assistance"); and,

WHEREAS the Participating Entities, through counsel or directly, FEMA, and CalOES have engaged, or will engage, in good faith discussions regarding the Participating Entities' commercially reasonable efforts regarding recovery of damages (including Disaster/Public Assistance) from PG&E; and,

WHEREAS the Participating Entities have engaged, or will engage, in good faith negotiations with PG&E regarding Participating Entities' legal damages, including those for which Participating Entities have received Disaster/Public Assistance ("PG&E Settlement Discussions"); and,

WHEREAS an anticipated Mosquito Fire Public Entities Master Settlement Agreement ("Master Settlement Agreement") would include one collective settlement amount to resolve all Participating Entities' respective legal claims, including those for which Participating Entities have received Disaster/Public Assistance;

The Participating Entities hereby enter into this Allocation Protocol Agreement (hereinafter "Agreement") to equitably and fairly allocate the collective settlement amount (hereinafter, "Global Settlement") among and between the Participating Entities, FEMA, and CalOES:

I. Damages Expert

- a. Industrial Economics (hereinafter "IEc") will serve as the common Damages Expert in connection with the Settlement Discussions (hereinafter, "Damages Expert").
- b. IEc is a qualified and unbiased economist and wildfire damages expert, appropriately selected for this Case.
- c. IEc will provide the common expert analysis for each and all Participating Entities, FEMA, and CalOES, with the intent to provide common and normalized methodologies for the calculation of the same or similar damages for each and all of the Participating Entities, FEMA, and CalOES. IEc will work with the

- Participating Entities, FEMA, and CalOES to agree on all amounts included in a Global Demand (as defined below) of PG&E.
- d. To the extent any Participating Entity, Damages Expert, or counsel learn or discover new information or errors that could affect any damages analysis, such new information or error shall not affect or change the pro-rata calculations and allocations agreed upon on the date of the first mediation. Participating Entities acknowledge that they have been given an opportunity to independently review and verify their respective individual damages. Accordingly, Participating Entities hereby waive and release Damages Expert, Baron & Budd P.C., and Diab Chambers LLP, from any errors, miscalculations or discrepancies that may ultimately affect their pro-rata recoveries and acknowledge that there is a risk that Participating Entities may receive more or less than they might be entitled to.

II. Baron & Budd, P.C. and Diab Chambers LLP

- a. During the PG&E Settlement Discussions, Baron & Budd and Diab Chambers LLP will advocate for and assert a global demand to PG&E for the legal damages of Participating Entities, which shall also include those losses, expenses, costs and the like for which Participating Entities have received Disaster/Public Assistance (the "Global Demand").
- b. The Participating Entities, FEMA, and CalOES agree there are no conflicts related to Baron & Budd P.C. and/or Diab Chambers LLP role and participation.
- c. FEMA and CalOES have represented to Baron & Budd P.C. and Diab Chambers LLP that FEMA and CalOES will agree in writing to share in their respective prorata fair shares of (1) attorneys' fees to Baron & Budd P.C. and Diab Chambers LLP of eighteen percent (18%) of the net recovery, and (2) costs; both of which will be deducted from their respective gross recoveries resulting from a Master Settlement Agreement with PG&E and Participating Entities; provided that FEMA and OES will not be required to pay any costs if there are no gross recoveries. FEMA and CalOES will confirm in writing that the pro-rata fair share of attorneys' fees and costs will be calculated on the same "net" basis as Participating Entities' attorneys' fees and costs, which includes attorneys' fees calculated "net" of costs, and all travel expenses are waived.
- d. The Participating Entities, FEMA, and CalOES will share pro-rata in accordance with this Agreement in any amounts the Participating Entities collectively receive in settlement of the claims that the Participating Entities assert, including those on behalf of FEMA and CalOES, against PG&E. Gross recoveries to FEMA and CalOES will be determined as described below in section "IV. Pro-Rata Allocation."
- e. Pursuant to agreements with FEMA and Cal OES, Baron & Budd P.C. will disburse from its Client Trust Account, the FEMA and Cal OES recoveries to each of the Participating Entities, which will then be responsible for providing any necessary reimbursements or credits to FEMA and Cal OES through agreed upon procedures between the Participating Entities, FEMA, and Cal OES. Once the FEMA and Cal

OES funds are disbursed from Baron & Budd P.C.'s Client Trust Account via wire transfer to a Participating Entity, the Participating Entity assumes full responsibility for the management of the FEMA and Cal OES funds.

III. Minimum Payment¹

- a. Each and every Participating Entity with a demand that is less than one hundred thousand dollars (\$100,000) shall receive a Minimum Payment equal to one hundred percent (100%) of their demand, not to exceed ninety-nine thousand nine hundred ninety-nine dollars (\$99,999), minus costs and attorneys' fees.
- b. Each and every Participating Entity with a demand that is greater than or equal to one hundred thousand dollars (\$100,000) shall receive a Minimum Payment of one hundred thousand dollars (\$100,000), minus costs and attorneys' fees.
- c. Each and every Participating Entity will receive at least the Minimum Payment by executing this Agreement and any Master Settlement Agreement for a Global Settlement.

IV. Pro-Rata Allocation

- a. The Global Demand will include the damages for each and all Participating Entities, including those damages for which Participating Entities have applied for and/or received Disaster/Public Assistance from FEMA and CalOES. Each damages category shall be treated with equal weight subject to the pro-rata allocation process.
- b. Each Participating Entity, FEMA, and CalOES will have an Allocation Percentage, calculated based on a Numerator and Denominator. The Numerator will be an entity's own total damages. The Denominator will be the total damages sum inclusive of the Participating Entities, FEMA, and CalOES.

V. Global Negotiation Process

- a. The Participating Entities will present to and negotiate with PG&E using one Global Demand Denominator, thereafter, engaging in one bilateral negotiation.
- b. Each Participating Entity's, FEMA's, and CalOES's respective recoveries will be reduced pro-rata (in accordance with the Allocation Percentages) as the bilateral negotiation reduces the Global Demand throughout the Global Negotiation Process.
- c. The Participating Entities have the discretion whether to resolve all claims included in the Global Demand Denominator, and Participating Entities will take into consideration all legal, factual, and strategic matters when deciding whether to resolve the claims within the Global Demand.

¹ The Minimum Payment assumes a successful litigation and resolution sufficient to meet these thresholds. The Participating Entities, FEMA, and CalOES understand and acknowledge that during the course of any litigation, there is risk that the litigation does not develop as planned and a settlement is not guaranteed.

d. Each Participating Entity must agree to a Global Settlement in order for that Global Settlement to have effect as to any Participating Entity. Nothing herein is a waiver or release of any rights whatsoever to control the outcome of an entity's case, and the choice to participate in a Global Settlement remains in its entirety for each Participating Entity.

VI. Memorialization and Finality

- a. The Participating Entities, FEMA, and CalOES will do all things necessary in a reasonable and timely manner to effectuate the memorialization and documentation of any Master Settlement Agreement for a Global Settlement, should a Global Settlement be reached.
- b. FEMA and CalOES have represented to Baron & Budd P.C. that as a condition precedent to receipt of any settlement funds, they will agree in writing to not pursue Participating Entities, PG&E, its contractors, affiliates, assigns, vendors, employees, directors, subsidiaries, insurers, or any third parties for those monies otherwise recoverable under the Stafford Act, 44 CFR §206.223(e); 44 CFR §204.62 (c);, and/or in 19 Cal. Code Reg. section 2910, or any monies paid or to be paid to Participating Entities in relation to or connection with the Mosquito Fire.
- c. FEMA and CalOES have represented to Baron & Budd P.C. that they will agree in writing as a condition precedent to receipt of any settlement funds, that the execution and substantial performance of the terms herein will satisfy any and all reimbursement and/or subrogation obligations from the Participating Entities to FEMA and/or CalOES, including but not limited to those described in the FEMA Public Assistance Program and Policy Guide, June 2020, at page 52; 44 CFR §206.223(e); 44 CFR §204.62 (c);, and/or in 19 Cal. Code Reg. section 2910. This Agreement and the performance of the terms herein shall not in any way replace, interfere with, or disrupt the usual and customary Disaster/Public Assistance claims process between and among the Participating Entities, FEMA, and CalOES.
- d. Each of the persons executing this Agreement warrants that they are empowered and authorized to so execute and have the authority to fully bind the Participating Entity or Participating Entities for whom they are signing to the terms of this Agreement.
- e. This Agreement may be signed in counterparts, which taken together shall constitute one and the same Agreement, and which may be signed and transmitted by facsimile or e-mail. Once this Agreement has been fully executed by all Participating Entities, any signed counterpart shall be equivalent to a signed original for all purposes.
- f. This Agreement constitutes the entire agreement of the Participating Entities and supersedes all other prior negotiations and agreements with respect to the subject matter hereof and thereof, except that the Participating Entities acknowledge that any joint prosecution agreement and/or confidentiality agreements (if any) heretofore executed between them shall continue in full force and effect.

- g. Unless expressly stated herein, this Agreement shall be solely for the benefit of the Participating Entities and no other person or entity shall be a third-party beneficiary hereof.
- h. This Agreement may not be waived, modified, amended or supplemented except in a writing signed by all of the Participating Entities.

Driver in stable condition after hitting tree

The Georgetown Fire Department responded to a traffic collision on Wentworth Springs just west of Lower Balderston Road at just after 4 p.m. Jan 17. A full-size GMC Yukon XL had run off the road into a tree.

Assisting Georgetown firefighters were personnel from the Garden Valley and El Dorado County fire protection districts, and CHP. Responding units include Georgetown Fire Chief 7100, Medic 61, Engine 361, Garden Valley Fire Squad 51 and El Dorado County Fire Engine 72.
